SUBJECT: ZONING APPLICATION – MONA BROTHERS

Mayor Yearta opened the meeting explaining this was a Zoning issue. Ms. Stephens addressed the Council stating this application was from Mona Brothers, property at 202 N. Westberry, which is currently residential. She is proposing to utilize the structure known as "apartment 2" for R-1 conditional use J. There is a letter of consideration from Ms. Busbee who plans to purchase the property for a beauty salon. Enclosed also were the deed, ads and sketch of the property. The beauty salon will not incur heavy traffic or fumes.

After consulting with Ms. Reid, it was decided that R-1 conditional use J would be the best scenario. The Planning Commission recommends approval of the application with the condition that the structure meets all applicable state fire safety codes. This zoning request is in Councilman Johnson's district.

Mr. Johnson thought it would be a perfect area for a beauty salon. Ms. Stephens said she believed there was ample parking for the shop.

There were no calls from the public regarding this request and no input from the public. The Mayor thought it was a good place for the shop and already in a semi-commercial location.
