## 4) **ZONING APPLICATION**

# 5) LOUD MUSIC AT CURTIS SHIPP PARK – IRA CHEEVERS

Mr. Cheevers presented the Council with a packet of documents covering prior sessions pertaining to Shipp Park. He was present at a session in 2010, and still having the same problem today-people not leaving park, not obeying park rules and parking, and confining music to inside of building. He feels it is unfair and an invasion of privacy. Music played from 8:30 til 11:40 pm. The Mayor, City Manager, and Mr. Powell were contacted. He asked why the PD do not follow the policy to shut down an event that violates rules. The original intent of the park was for kids, but now it is an adult facility for parties. He has called 911 countless times in the past years.

Mayor Yearta said the park should be closed at sundown. It was decided that all park guidelines and policies should be visited at a work session.

## ASPIRE BEHAVIORAL HEALTH SERVICES – JOEL VANDENBERGH

Mr. Powell informed the Council that this is done every year. When school is out, they utilize the Hut to see the children.

## 7) ADMINISTRATOR and ENGINEER CDBG SELECTION FOR 2019 – JACK COLBY

Councilman Johnson moved, seconded by Councilman Powell that based upon a review of the proposals received, the scoring of the criteria on the administrative worksheets, and following discussion of the proposals, City hired Bob Roberson as administrative consultants, and Carter and Sloope as engineering consultants, to design, and to complete CDBG projects for the City as proposed.
