VI. NEW BUSINESS

A) City Internet System Technical Services Agreement

Mr. Hayes introduced Marvin Golden, a representative of NTS, to explain details of the proposed contract. Mr. Golden spoke briefly on creating a cyber system that allows citizens to work from home and businesses. He also informed the Council that they would be responsible for pooling resources to make the

venture successful. They will soon begin "make ready" for the poles, with the City having an advantage by owning their poles. In comparison to other Cities, Mr. Hayes asked about the advantages and disadvantages of broadband for the City of Sylvester. Mr. Golden noted that to present, everything has been done right and they would devise a sound business model. Mr. Hayes made known that the goal was to provide services comparable and affordable to the public. Mr. Hayes recommends approval of the contract with NTS.

Councilman Johnson motioned to approve the NTS agreement and a second was offered by Councilman Jackson – *Motion Carries 4-0*

B) HALLOWEEN EVENTS
