ATV, MINI BIKE, DIRT BIKE, UTV, GOLF CART ORDINANCE

In keeping up with public and traffic safety, the City of Sylvester is revising their ordinance on the above-mentioned units. The City had a previous ordinance which allowed D.O.T. certified UTV and Golf Carts to be ridden in the city limits. This ordinance will replace that ordinance. The new ordinance is as follows:

1. ONLY UTV AND GOLF CARTS WILL BE ALLOWED
2. UTV AND GOLF CARTS MUST HAVE OPERATIONAL BLINKERS, HEADLIGHTS, TAIL LIGHTS AND A HORN.
3. UTV AND GOLF CARTS MUST FILL OUT AN APPLICATION FROM SYLVESTER POLICE DEPT., HAVE INSPECTION DONE BY A SYLVESTER POLICE OFFICE AT THE SYLVESTER POLICE DEPT. THEN RETURN INSPECTION FORM TO CUSTOMER SERVICE FOR A CITY DECAL. FORMS WILL BE AVAILABLE MONDAY THRU FRIDAY 8:00 TO 5:00 EXCEPT HOLIDAYS.
4. CITY DECALS WILL BE GOOD FOR ONE YEAR. YEAR WILL RUN FROM JANUARY TO DECEMBER. AN INSPECTION MUST BE DONE EACH YEAR WHEN RENEWING YOUR DECAL.
5. OPERATORS OF THE UTV OR GOLF CART MUST BE 15 YEARS OF AGE ACCOMPANIED BY A LICENSED DRIVER AND OR BE 16 YEARS OR OLDER AND HAVE DRIVERS LICENSE IN GOOD STANDING.
6. UTV AND GOLF CARTS WILL ONLY BE ALLOWED ON CITY STREETS. NO UTV OR GOLF CART WILL BE ALLOWED AT ANYTIME ON HWY. 82, HWY. 112, HWY. 313, HWY. 33, AND HWY. 256.

VIOLATIONS TO THE ABOVE ORDINANCE WILL BE AS FOLLOWS:

FIRST OFFENSE: WRITTEN WARNING
SECOND OFFENCE: WRITTEN CITATION WITH FINE
THIRD OFFENCE: WRITTEN CITATION WITH FINE.
IMPOUND OF UNIT FOR 30 DAYS WITH STORAGE CHARGES, STORAGE FEE WILL BE \$10.00 PER DAY.
FOURTH OFFENCE: SEIZURE OF UNIT, WRITTEN CITATION WITH FINE
FIFTH AND FINAL: SEIZURE OF UNIT, WRITTEN CITATION WITH FINE AND BAN FROM HOLDING A DECAL.
