- ➤ Keys may be picked up the day before the building is rented. In the instance that your rental day falls on the weekend, please pick your key up the Friday before.
- ➤ All keys are due back the next business day by 5:00. You may put the key in the overnight drop box or bring it inside the depot office.
- **>** Bouncy houses and/or water slides are **not** allowed at any of the buildings.
- ➤ <u>No</u> alcoholic beverages are permitted at any building rentals.
- If you are having an event that you will be charging a fee for or need to have roads closed, it is your responsibility to let the clerk know. There is a separate event form/road closure form that will need to be completed and approved by management before you may hold your event.
